Dear Parents,

As you are aware 7th pay commission has come into force w.e.f 1.1.2016 whereby the school has additional cost of 25-27% in salaries to the staff. Directorate of Education has issued guidelines vide their circular dated 17.10.17 for implementation of 7th pay commission with corresponding hike in tuition fee. The school is implementing the 7th pay commission w.e.f. 1.4.17 instead of 1.1.16 so as not to burden the parents with fee hike for the period from 1.1.16 to 31.03.17. As per the guidelines and as approved by the parents in their meeting, the school has submitted the online proposal for fee hike to Directorate of Education. Meanwhile, as permitted, the school is collecting the interim fee hike of 7.5% for the period from 1.4.17 to 30.6.17 and 15% thereafter and the balance shall be collected as per the decision of DOE.

You are also aware that the school has collected increased tuition fee during April 16 to July 16 which is also being refunded and adjusted from the arrear fee now payable by you.

You will also be glad to know that school LMC has decided to refund the students security of Rs. 500/- now instead of at the time of leaving the school so that the burden of arrears on parents is reduced.

In this respect, please note that:-

1. The student admitted during the current year 2017-18 will have to pay the arrears as per column (H) above.
2. The students admitted during the year 2016-17 and before will have to pay the arrears after adjusting the excess fee paid by them during 2016-17 as per column (K).
3. Col (I) is applicable only to those parents who have paid the fee for the month of April'16 to July'16 and those who have paid the fee in advance i.e. beyond July will also be adjusted at the time of submission of fee.
